### Emissions reduction targets

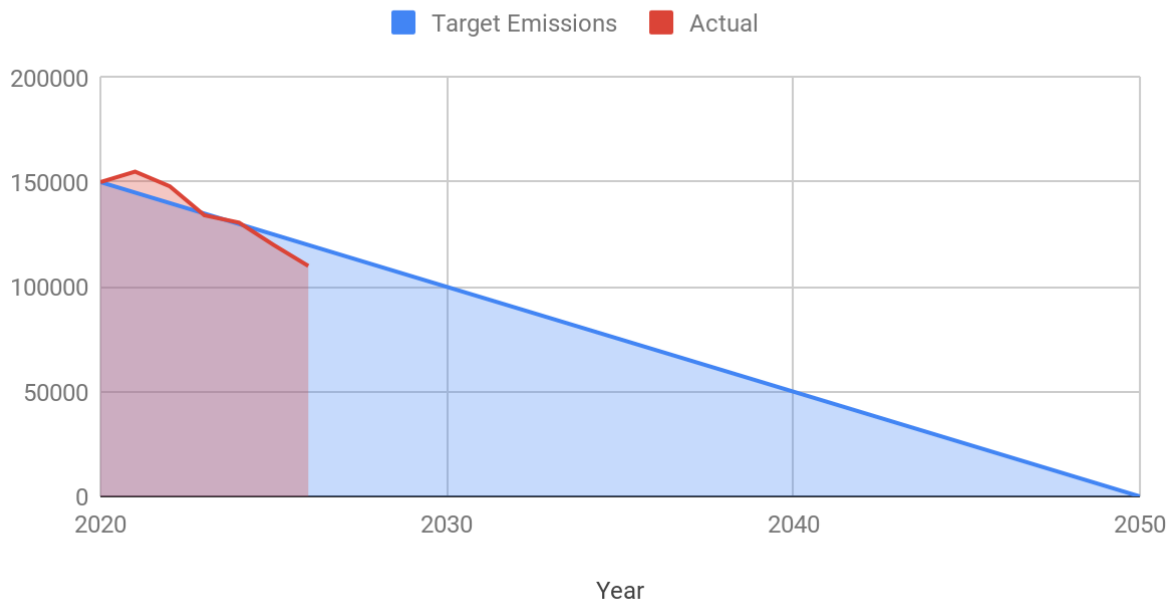
This is Social Changes first emissions reduction commitment and our organisation’s first carbon footprint.

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 50 tCO<sub>2</sub>e by 2028. This is a reduction of 35%

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been implemented since the 2022 baseline.

At Social Change we encourage our team to walk or cycle into work where possible. For business meetings we encourage this to be via online meetings where possible to reduce the need for travel. Where travel is required, public transport is the preferred option, where this is possible car-pooling must be used by the team.

Within our offices we have recycling bins and try and encourage a paper free environment where possible.

In the future we hope to implement further measures such as:  
Move to a more sustainable office and purchase an electric company car.
